RE: AUTHORIZING THE APPROPRIATION OF \$1,498,624.00 FOR KIRKLAND TRAILS PROJECTS

BE IT RESOLVED by the Town Board for the Town of Kirkland, Oneida County as follows:

**WHEREAS**, the Town of Kirkland (the "Town") is a municipal corporation organized and existing pursuant to the laws of the State of New York; and

**WHEREAS**, pursuant to the Town of Kirkland Comprehensive Land Use Plan (last revised June of 1993), the Town recognized the importance of promoting recreational activities including the use of recreational trail systems; and

WHEREAS, "Kirkland Trails" is a committee of citizens formed to undertake steps to advance the concept of developing and utilizing multi-use Bike/Hike trails (the "Project"); and

**WHEREAS**, the Town of Kirkland is the recipient of a \$1,498,624.00 grant to develop multi-use and Bike/Hike trails; and

WHEREAS, pending receipt and administration of grant monies, Kirkland Trails requires the advance of funding for construction and development of multi-use trails and is willing to advance \$200,000.00 of its own funds toward the Project; and

**WHEREAS**, the Town is desirous of pursuing recreational trail opportunities on certain conditions consistent with and in concert with Kirkland Trails; and

**NOW THEREFORE, BE IT RESOLVED**, that the Town of Kirkland to appropriate the sum of \$1,498,624.00 from Capital Account #5115.2 which includes cash and proceeds from bond anticipation notes, for 2023 TAP: Kirkland Trails Phase II, which sum shall be reimbursed as grant funds; and it is further

**RESOLVED** that the Town Supervisor is directed to take such steps as are necessary to prepare, implement and administer those funds, applications, permits and duties as are reasonable and prudent to carry out the intent of this Resolution; and it is further;

**RESOLVED**, that this Resolution shall take effect immediately.
